# **Secretary Carmel Roques**

  - Prepare for Marylanders living longer;
  - Fill vacancies;
  - Increase and push out State and Federal funds to Area Agencies on Aging; ensure equity in funding spending;
  - o Combat elder justice, abuse and neglect; and
  - o Engage and collaborate with multi-agency sectors.

# Recommendations from Federal and State Level Secretary Carmel Roques

- Administrative Goals
  - Improving state and local service delivery to seniors by filing vacancies;
  - Strengthen MAP/No Wrong Door programs;
  - Increase affordable and accessible housing with services;
  - o Expand Community Options Waiver, lessen wait time;
  - Affordable medication;
  - O Assist with food insecurity with the reduction of SNAP benefits;
  - Improving existing Long Term Care facilities by using Federal funds for better oversight, compliance; staffing and higher wages in facilities;
  - O Combat elder abuse, exploitation and fraud; and
  - o Engage and collaborate with multi-agency sectors.

### **Approval of Minutes**

Virginia Crespo made a motion to approve the minutes from the November 30, 2022 meeting. Minutes were approved.

#### **Review Consensus Study Report April 2022 Highlights**

**Recommendations and Goals** 

- Not meeting daily basic needs;
- Improve quality of care and nursing home settings;
- Improve quality of food;
- Review how money is being spent, budgeted;
- More staff, training, exceed minimum staff requirements, higher wages, improve work environment;
- Lack of compensation for room and board;
- Reliable transportation to outside appointments;
- Shorten wait times for doctor appointments;
- Possibly engage with Moving Forward Coalition <a href="https://movingforwardcoalition.org/">https://movingforwardcoalition.org/</a>;
- Suggested that State could maintain background checks for new staff; issue is that each facility
  needs to meet requirements but may add their own restrictions; each facility needs a
  background check for a new staff member even if they came from another facility and had a
  recent background check completed; same as with credentialing physicians; and
- Inadequate equipment.

#### **Update/Reporting on Legislation on Transparency**

• The Bill on transparency introduced this session related to a sale of a facility, passed both houses. Brings ownership ratings from another state to Maryland. OHCQ is able to offer provisional license if they have low quality ratings.

• Maryland has a list of nursing home ownership. Information is not easily understandable.

# Increase Staffing in Assisted Living Facilities and Nursing Homes Ideas/Challenges

- Create a pathway at the High School level for staffing;
- Harder to get older employees return to work;
- Increased training; and
- Increase Funds for Community Waiver Program.

# **Assisted Living Regulations and Affordable Assisted Living**

- Final Regulations delayed due to MDH IT security incident;
- Regulations comments will be posted on website;
- Challenging to meet consensus on regulations, if not met they will leave as is;
- Concern with affordability of facilities; and
- Ask a member of MHCC to speak with Committee on affordability.

# **Updates and Announcements from Committee Members**

- The Committee meets quarterly. Suggestion to add a few shorter meetings in between as needed;
- Annual Report due December 1; and
- Need to fill Committee vacancies. The Department will follow up with the Appointments Office.
