Review of Bill HB636

- Required to conduct a study regarding the quality of care provided by certain assisted living programs; and generally relating to a study of assisted living programs.
- Final report due October 1, 2023.
- Focused on analyzing three parts of the bill:
 - Quality of care.
 - o Costs.
 - o Emergency reporting system.

How the State can help based on analysis

- Offer regulatory guidance.
- Provide specialty training.
- Offer resources for infraction prevention and control.
- Expand reimbursement options.
- Provide no or low cost general health care training for staff.
- Offer employment incentives.
- Increase level of reimbursement.

Draft recommendations

- Immediate Priority
 - Require assisted living programs to maintain a valid email address and internet access for ongoing communication and data exchange.
 - o Establish definition for small assisted living programs.
 - Improve interagency data sharing.
 - Facilitate compliance with disclosure and transparency requirements associated with CMS annual survey results.
- Two year priority
 - O Data collection and needs assessment for access to Assisted Living Program services
 - Data sources.
 - Appropriate state agency.
 - level of state resources required to maintain the needs assessment process.

- Five year priority
 - O Public education and awareness.
 - o Technology implementation.

Next steps

- Compete draft final report and distribute for feedback.
- Present recommendations to the September MHCC commission meeting.
- Finalize report and submit to legislature by October 1, 2023.
